1. Welcome:

Dan Kahl presided over the meeting and welcomed everyone.

2. Member Introductions/Roll Call:

Members were invited to introduce themselves and to tell what their roles were at their respective institutions.

3. Additional Agenda Items:

The agenda was reviewed-there were no additional agenda items.

4. Approval of PLC Mid-Winter Meeting (January 11&12) Minutes:

The minutes were reviewed and approved as read with no changes, only grammatical errors which will be corrected. Cheryl made a motion to approve the minutes as read, with Dan Goerlich seconding. The motion passed

5. Update from AEA:

Dr. Essel reported:

➤ The Association of 1890 Research Directors will be holding a symposium April 2-5 at the Atlanta Marriott Marquis Hotel in downtown Atlanta. The theme for the conference is "The 1890 Research and Innovation Agenda: Pathways to Build Back Better". Will probably be around 1000 participants, looking for a successful conference.



Planning continues for the 2022 AEA System-wide Conference, which will be held July 31-August 4 in Orlando.

- ➤ The 1890s Foundation is celebrating it's fifth anniversary from February 21-25. They are offering a series of virtual events. The theme is "The 1890 Mission Forward", bringing people in from government, industry, other areas. The public is invited to attend.
- AEA joined in the discussion on the Board on Agriculture Assembly (BAA) Committee on Legislation and Policy (CLP), started discussions on the Farm Bill. Lewis Burke and Associates is the new advocacy group for the APLU Board of Assembly-they are guiding in discussions on priorities in the Farm Bill. Last week, AEA, along with other regional associations in the Southern Region. We are looking to have all (1862, 1890, 1994) of the Extension NIFA budget lines reauthorized.
- ➤ AEA participated in discussions with regards to the 2023 appropriations. Budget and Advocacy committees met to discuss priorities for each of these sections. Continuing to use the unified ask model.

6. Update from ASRED:

Dr. Ron Brown reported:

- Adding to Dr. Essel's report, recommending the removal of the 30% cap on indirect cost recovery and removing the match requirement for special crop research initiatives and the Beginning Farmer and Rancher Development Program.
- ➤ Looking to increasing authorization level of Smith-Lever 3D from \$60M to \$150M to make room for funding if we could get it on climate and Community Learning Through Data Driven Discovery (CLD3).
- > Dr. Rick Avery to replace Dr. Jeff Hyde as Director of Texas A&M AgriLife Extension
- ➤ Dr. Gina Eubanks has been appointed by the Secretary of Agriculture to the 15-member Equity Commission on Agriculture, committee will provide recommendations to the Secretary on policies, programs, and actions needed to address equity issues in USDA.
- > Dr. Tom Dobbins approved as ECOP's representative to the Journal of Extension board.
- > NIFA- Some executive level employees returning to the office.
- Impacts Database-Southern Region did well. 380 impact statements 212 were Cooperative Extension. NIFA can use these as talking points to SecAg.
- Excellence in Extension and Diversity Award deadline is May 1. First year that we are going to have team awards.
- ➤ Directors-discussing issue-based program and meeting structure for PLN. Encouraging us to talk about how we might meet and organize our work to look at some of the major issues in Extension, such as climate, broadband, health, workforce development. Important to look across committees at some of these issues.
- Excellence in Extension-Southern Region has captured that award 7 of the last 10 yearsspeaks well of the region.

Michelle has been working through the channels to get USDA Deputy Secretary Jewel Bronough as guest speaker. She hasn't received a definitive answer, and her contact there said that it may be difficult to get an answer this early and suggested a second speaker as backup. The group was not excited about that suggestion. One option, keeping it in Deputy Secretary Bronough's office was to pursue Dr. Shefali V. Mehta, Deputy Under Secretary for Research, Education, and Economics, or someone in her office. Michelle is in contact with Michele Simmons with ARS to facilitate this.
